**Re: Improved planning controls for sustainable buildings and urban ecology**

The Council Alliance for a Sustainable Built Environment (CASBE), the Eastern Alliance for Greenhouse Action (EAGA), the Central Victorian Greenhouse Alliance (CVGA), the Goulburn Broken Greenhouse Alliance (GBGA), the Northern Alliance for Greenhouse Action (NAGA), the South East Councils Climate Change Alliance (SECCCA) and the Western Alliance for Greenhouse Action (WAGA) would like to raise some important issues relating to planning controls for sustainable buildings and vegetation in urban areas.

On behalf of our member councils we urge you to:

**1. Support the Cities of Brimbank, Greater Dandenong, Greater Bendigo, Hobsons Bay, Kingston, Whittlesea and Wyndham in their efforts to realise a local ESD planning policy.**

As you are aware, a growing number of councils are providing detailed guidance on sustainability in buildings through local Environmentally Sustainable Development (ESD) policies in their planning scheme. To date ten councils have gazetted policies, and another seven are in the process of an amendment. We applaud your decision to extend the expiry dates for the existing local ESD policies (until June 2019), and we welcome the consideration of your department of local ESD policies by the Cities of Brimbank, Greater Dandenong, Greater Bendigo, Hobsons Bay, Kingston, Whittlesea and Wyndham.

Furthermore, we would like to emphasise that with the trigger for these policies typically being 2 or more dwellings, or +1000m<sup>2</sup> for non-residential building, these policies are applicable for all council types, whether metropolitan, regional or rural.

**2. Support a more comprehensive approach to sustainable built form.**

The local ESD policies are a necessary and vital step in the right direction, although they are only a part of a bigger picture. To fully realise the potential for adaptive and resilient buildings and cities, we believe additional, more detailed guidance is required in a number of areas.

We seek a more comprehensive, holistic approach to sustainable built form that encompasses not only resilient, adaptable buildings, but also green infrastructure, integrated water management, integration with emerging transport options, energy efficient designs and more socially sustainable structures.

We also seek an approach that does not disadvantage rural and regional councils with limited resourcing to implement planning amendments.

We are encouraged by some of the work by your department and industry in this area, in particular

- DELWP's review of Victoria's land use planning and building systems, to improve the management of natural hazards in these systems in the context of climate change – the ***Improved management in the planning and buildings systems of natural hazards in light of climate change*** Discussion paper.
- DELWP's commissioning of CSIRO's Climate Science Centre (CSC) to develop a high-resolution climate projections data and guidance package to deliver dynamically downscaled projections covering all of Victoria. This will assist planning and building legislation to understand and incorporate projected regional climate change impacts, extreme weather events and insights into climate change adaptation planning.
- Resilient Melbourne – **Melbourne Metropolitan Urban Forest Strategy**.
- **Plan Melbourne 2017-2050** which commits to creating urban forests throughout the Melbourne metropolitan area (Policy 6.4.1, Action 91). It is a whole-of-government commitment that includes a package of initiatives to facilitate a cooler, greener and more liveable city. Also Action 85 relating to the 'improvement of natural-hazard, climate change and environmental adaptation and risk-mitigation strategies in the Victorian Planning Provisions' (p.11).
- **Victoria's Climate Change Adaptation Plan**, which includes the action 'review land use planning policies and provisions to improve the way the land-use planning system manages natural hazards, climate change and environmental risks' (p.48).
- **Vegetation cover, heat and land-use data** project being undertaken collaboratively between DELWP, CSIRO and RMIT.
- **The Smart Planning program**, which seeks to improve the clarity, transparency, and accessibility.

**3. Fast track the consideration and introduction of clear and specific requirements for urban ecology within the Victoria Planning Provisions, to prevent further unnecessary vegetation loss.**

Current rates of development and approaches to site coverage are resulting in a high level of urban vegetation clearance. This loss of vegetation not only results in less green space and adverse ecological impacts, but has unintended impacts such as reduced soil stability and issues related to ground and storm-water management.

Our council members have experienced situations where developers would rather pay a fine for removing significant vegetation than implement strategies to retain it. Despite the best efforts of local government, urban vegetation is being cleared at a faster rate than can be replaced in the public realm. Our members' efforts to increase urban vegetation in the private realm are challenged with the limitations of the current planning controls.

**4. Support the establishment of a working partnership between DELWP and local government on the future of ESD in planning.**

With our collective membership we have a wealth of experience in ESD in planning.

We would welcome the opportunity to develop a collaborative partnership with your department on developing an approach to mandatory ESD controls for buildings in our planning framework. We believe planning is an important part of the solution towards a sustainable future for our cities, suburbs and towns.






