### ABOUT EAGA

The Eastern Alliance for Greenhouse Action (EAGA) is a formal collaboration of eight Councils in Melbourne's east, working together on regional programs that reduce greenhouse gas emissions and facilitate regional adaptation. The Alliance implements joint initiatives that provide economies of scale and enable projects typically beyond the reach of individual Councils. EAGA's project work is complemented by advocacy, capacity building and regional partnerships.

## CHAIR PERSON'S STATEMENT

I am pleased to present EAGA's annual report for the 2018-19 year. The ongoing commitment from our members continues to be underpinned by the clear financial and greenhouse savings that EAGA continues to deliver to communities in Melbourne's East.

A big development for us this year has been the emergence of Environmental Upgrade Agreements (EUA) across Knox, Maroondah, Yarra Ranges and Monash. This was only possible in part due to EAGA's advocacy in the previous Council term which led to the introduction of EUA legislation across Victoria. In our region alone, EUAs will result in large reductions of emissions for many local businesses, including the largest solar EUA in Victoria, a \$1.4 million system installed at Tibaldi in Clayton. Our advocacy efforts continue in the hope that we will realise similar successes into the future.

The continuation and expansion of EAGA's joint energy performance contracting program has been another noteworthy success for the Alliance. The second tranche of councils will cut energy usage and operating costs in large council facilities through a delivery model widely viewed as best practice across the sector. This work has leveraged the outcomes of the first tranche of councils who are now verifying annual savings of over \$200,000 per year per member.

We've continued to lead a number of projects across the region and beyond, including advocacy on reducing emissions from major road lighting, the expansion of the Solar Savers program, exploring the feasibility of communityowned renewable energy infrastructure, and of course involvement in the Local Government Power Purchasing Agreement. This Agreement will help Victorian councils save money while reducing greenhouse gas emissions through their electricity contracting, procuring low cost energy from 2020/21 and helping many councils move to 100% renewable energy.

EAGA's successes have continued to grow over the last twelve months, due to the commitment and passion of our staff and committees. I have been extremely proud to Chair this exemplary organisation for another term, and I thank my colleagues for their support. I would particularly like to thank and commend our Executive Officer, Scott McKenry on another excellent year.

## SUMMARY OF 2018/19 OUTCOMES AGAINST STRATEGIC PLAN

Strategic Direction	Initiative	Outcomes
Mitigation and adaptation projects	Solar Savers	The program's grant funded pilot concluded in June 2019 and successfully delivered 434 solar systems installations, generating approximately 1.6 MWh of power and saving 1,749 t of CO2-e emissions annually. Final evaluation data demonstrated a net benefit of \$292/year for each participating low-income household. Over 40% of all installations in the State were delivered in the EAGA region, leveraging an investment over \$1.1M in clean energy for the communities in Melbourne's East. A group of ten councils have committed to supporting the program in 2019/20, under a new business model independent of grant funding. The initiative is overseen by EAGA's Solar Savers Program Leader, Anna Imberger.
	Energy Performance Contract (EPC)	The scope of EAGA's joint EPC program has been extended to capture an additional 13 large council facilities, including energy intensive aquatic centres in Knox and Whitehorse. Both councils have engaged a specialist engineering provider to deliver the program through a joint procurement and shared service management model. The first tranche of councils (Boroondara, Maroondah, Yarra Ranges) each benefited from ~\$200K/yr in savings and 1,500 tonnes of abatement from energy conservation implemented in the previous financial year. It is anticipated that Whitehorse and Knox will secure similar savings in the coming financial period. The initiative is led by EAGA's Energy Projects Officer, Russell Boehm.
	Scaling Up Solar on Council Facilities	Five EAGA councils completed delivery of collaborative business cases for procuring and implementing behind the meter solar on council facilities. The project systemically assessed and prioritised 'second tier' sites (outside the EPC project), reviewed alternate contracting models (including leases) and developed a series of procurement templates and resources for use by all Victorian councils. The analysis has provided councils with an investment plan for the roll-out of 935kW of solar at 53 sites for the coming financial periods.
Capacity building and information exchange	Local Government Power Purchasing Agreement (PPA)	In collaboration with the Victorian Greenhouse Alliances and the City of Darebin, EAGA has continued its key role in the establishment of the LG PPA - a landmark initiative that will enable 48 Victorian councils to procure low cost renewable energy from 2020/21, at the conclusion of existing retail contracts. Once finalised, the initiative will be the largest ever emissions reduction initiative in the Australian Local Government sector. Seven EAGA members have committed between 40-100% of their annual electricity load towards the initiative.
	Major Road Lighting	EAGA has initiated a pilot 'metering' program aiming to ensure that savings generated through smart controls on public lighting infrastructure (i.e. dimming, trimming and other energy savings options) can be captured on energy bills. The project is being conducted in partnership with Ironbark Sustainability and the Australian Energy Market Operator (AEMO) with this intent to progress changes to the National Electricity Rules.
	Victorian Greenhouse Alliance Conference	EAGA collaborated with the Victorian Greenhouse Alliances to deliver the third joint conference attended by over 300 local government (and other) representatives from across Victoria. The event was held at Melbourne Convention and Exhibition Centre and featured a number of high-profile key note addresses and showcased the depth a sophistication of local government projects from across the country.
Advocacy	Submissions	Five formal advocacy submissions were developed over the course of the year covering key federal and state issues including energy market reform and climate change policy. This advocacy was particularly effective on the issue of rooftop solar where EAGA and its partners were successful in securing modifications to the State Government's solar rebate program to ensure its alignment with council led programs, such as Solar Savers.
	Engagement	EAGA and the Greenhouse Alliances have been providing an ongoing vehicle for councils to have a coordinated conversation with the State Government regarding the sector-based adaptation plans and Victoria's emission reduction targets. EAGA continues to represent local government on a number of key committees, including Ausnet Services Customer Consultative Committee where issues of importance to councils can be directly raised with the distribution business' CEO and Directorate.



IMPACT

For every dollar invested in EAGA's membership fees and projects, the region's councils and communities capture \$2.30 in financial savings.
