Dear Ministers D'Ambrosio, Leane, Pearson, and Wynne,

Re: Proposed Planning Reforms

On behalf of their member councils, the Victorian Greenhouse Alliances and the Council Alliance for a Sustainable Built Environment (CASBE) would like to express our concern regarding the State Government's proposed planning reforms scheduled for presentation to Parliament this November.

The reforms are expected to change how planning decisions are made and how the planning system operates whilst assisting Victoria to recover from the pandemic through accelerating growth. Although improvements to the planning system are welcomed by councils, it is critical that the reform process be underpinned by deep and meaningful engagement with key stakeholders - particularly local governments, which are also local planning authorities and therefore central to the system. Thus far, consultation has been extremely limited and engagement with elected community representatives has not taken place.

Importantly, this review provides a critical opportunity to ensure Victoria's planning system is aligned with the State's legislated emission reduction targets and supports climate resilient communities. It also provides an opportunity to ensure the delivery of zero-carbon infrastructure, building on Victoria's leadership role on taking action on climate change.

The work to identify and develop these necessary improvements to Victoria's planning system is currently being undertaken through an independent review commissioned by the Victorian Greenhouse Alliances and CASBE. This work has identified a raft of reform opportunities that will be provided to the *Inquiry into the Protections within the Victorian Planning Framework* and improve the long term value of proposed planning reforms.

We would welcome the opportunity to speak with you directly regarding the review findings and discuss how we can contribute to the Government's reform objectives and the issues outlined above.
