#### The Eastern Alliance for Greenhouse Action

(EAGA) is a formal collaboration of eight Councils in Melbourne's east, working together on regional programs that reduce greenhouse gas emissions and facilitate adaptation. The Alliance implements joint initiatives that provide economies of scale and enable projects typically beyond the reach of individual Councils. EAGA's project work is complemented by advocacy, capacity building and regional partnerships.

#### Chair Person's Statement

This year saw EAGA's eight member councils renew their commitment to working regionally to address climate change via a new four-year Strategic Plan with a new mission to facilitate the region's transition to net zero emissions by 2030. I was proud to see this step-change in the level of ambition, particularly in response to the emergence of the latest IPCC science demonstrating the urgency of halving global emissions within the next decade and the increase in severe weather events in our region. The local and ongoing impacts of the June 2021 storm events continued throughout the 2021–22 period and have had profound consequences for council across Melbourne's east.

Importantly, EAGA has continued to lead the sector's work into understanding the costs of climate impacts on community assets and infrastructure. The Adaptive Community Assets project will provide critical information on the financial risks to road, buildings, drainage and natural assets for each council in Greater Melbourne. This information will be critical for assisting local governments to incorporate climate change into their long term financial planning and ensure they are meeting their obligations to manage risks under the Local Government Act 2020.

Our members have made significant progress on reducing their corporate emissions, particularly through initiatives such as the Victorian Energy Collaboration (VECO) which has also delivered substantial cost savings in a time of unprecedented energy market volatility. Whilst this is a great achievement, it's important to keep in mind that the emissions from council operations only represent ~1% of community emissions. Consequently, EAGA has commenced an important body of work to identify the lowest cost emissions reduction opportunities across the region, and then quantify the 'best bang for buck' council led interventions. This work will clearly identify the role of councils and be used to inform our annual planning process and advocacy towards other sectors and levels of government regarding their own roles in the transition to net zero.

The ongoing persistence of EAGA's advocacy work is continuing to deliver key outcomes, particularly in the area of energy market reform, where the incoming Federal government has announced some of the changes to the National Electricity Rules that EAGA has called for in seven formal submissions in the last seven years. This change will finally enable the market's legal framework and its various institutions to expedite the decarbonisation of the grid, rather than hinder it. EAGA was also successful in advocating for other key reforms on embedded networks that will help ensure tenants are protected and the integration of renewables is actively supported.

Our achievements have been underpinned by the dedication and hard work of our committees and growing team. I would like to thank my fellow representatives on the Executive Committee, the Steering Committee and our staff for another excellent year.



### Summary of 2021–22 outcomes against strategic plan

Strategy Direction	Initiatives	Outcomes
Mitigation and adaptation projects	Victorian Energy Collaboration (VECO)	Six EAGA members are part of a buying group of 51 councils who have switched to 100% renewable energy via a Power Purchase Agreement (PPA) with Dundonnell and Murra Warra windfarms. The sector changing initiative has slashed electricity bills for the participating councils, delivering energy ~25% cheaper in the first 12 months. EAGA councils have saved 41,000 tonnes of emissions since VECO launched in 2021.
	Energy Savers	Energy Savers is a program assisting businesses undertake energy efficiency upgrades with subsidised appliances and equipment. EAGA secured over \$240,000 in state funding to scale-up the program which engaged with over 1,560 businesses over the year. Over 600 upgrades will save businesses in the region ~\$370,000 annually and cut emissions by 1,300 tonnes. Energy Savers is being administered by Monash City Council on behalf of the eight participating councils.
	Solar Savers	EAGA's longstanding solar program was extended to businesses from 1 July 2021. Solar Savers delivered 0.7MW of rooftop solar in the last 12 months which will cut emissions by over 900 tonnes per year. This included two rates programs involving councils investing their own funds to pay the up-front costs of solar systems on vulnerable households and recouping the funds via rates charges.
Capacity building and information exchange	Electric Vehicle Transition and business case	The project involved a holistic assessment of the financial, social and environmental costs and benefits for fast-tracking the electrification of council vehicle fleets. The analysis showed that the cost of transition was on average only 17% more expensive than business as usual (based on current pricing) but this cost gap is expected close each year, reaching price parity by 2030.
	Adaptive Community Assets	The first phase of this DELWP-funded project delivered a cost benefit analysis framework for councils to undertake business case assessments of the best adaptation options for community assets and infrastructure. The project was delivered in partnership with four metropolitan Greenhouse Alliances.
	Community Net Zero Technical Analysis	This project seeks to identity opportunities councils can take to reduce emissions from the community sector, which accounts for around 99% of the region's emissions. The technical analysis quantifies the emissions profile of each municipality and identifies the lowest cost opportunities for the region to transition to net zero by 2030. The analysis demonstrates that the region can capture significant financial savings in the process and that councils have a key role to play in unlocking these opportunities, particularly in planning, waste and transport.
Advocacy	Energy market reform	After seven years of advocacy by EAGA other energy advocates, the Federal Government will finally revise the National Electricity Objective (NEO) to include emissions reductions. EAGA also successfully advocated for changes to regulation on embedded networks requiring all networks to be powered by 100% renewable energy, as well as strengthening tenants' rights Advocacy outcomes from previous years continue to deliver financial savings to councils in the 2021–22 period.
	Planning for a Safe Climate	EAGA partnered with the Victorian Greenhouse Alliances and the Council Alliance for a Sustainable Built Environment (CASBE) to deliver a state-wide campaign to reform Victoria's planning system. The first stage of the campaign involved building the case for reform through an independent assessment of planning policy, legislation, regulation and practices. 64 of the state's 79 councils are involved in this campaign, representing one of the largest, most coordinated advocacy campaigns led by the local government sector.

EAGA drives collaboration, knowledge -sharing and joint initiatives across Councils through its strong community of practice and we look forward to continuing this successful partnership in 2023."
