Dear Minister Blandthorn,

Re: Planning for a Safe Climate for Victorians

The Eastern Alliance for Greenhouse Action (EAGA) is a formal collaboration of eight Councils in Melbourne's east, working together on regional programs that reduce greenhouse gas emissions and facilitate adaptation.

Our councils are part of the [Planning for a Safe Climate](#) advocacy campaign initiated by the Victorian Greenhouse Alliances and the Council Alliance for a Sustainable Built Environment (CASBE) - formal partnerships of over 70 councils and authorities across Victoria.

We commend the work that the Victorian government is doing to reduce emissions and support Victorians to adapt to climate change. However, there are flaws in the planning system that harm the ability of councils to carry out their duty to tackle climate change. Land-use changes are major contributors to the production of greenhouse gas emissions through their shaping of energy production and consumption, agriculture, industry and transport patterns. As you know, decisions made today will be seen in buildings for decades to come - more than half of Australia's 2050 building stock will be constructed during the next 30 years. Therefore, it is crucial to eliminate the disconnect between high level policy positions on climate change — both by State and local government and day-to-day planning decisions — by making our planning system fit for purpose.

Improving the planning system is expected to deliver the following benefits:

- Cost of living - efficient homes and buildings are cheaper to operate and can reduce exposure to rising energy prices
- Disaster relief - reducing physical risks to climate hazards will potentially save billions in disaster recovery costs
- Support the energy transition - achieving the State's renewable energy targets will be enabled through decreasing energy demand and supporting distributed energy resources
- Health - research demonstrates that the healthcare system can capture significant economic benefits from increasing the quality of housing stockⁱ
- Planning application times - providing clarity to planners and applicants will eliminate ambiguity and fast track approvals

The Alliances wrote to you last month, after sending you information and requesting a meeting earlier in the year. The correspondence so far has outlined the need for change and most recently asked you to formally confirm your support of four asks as per the Report Card attached.

We are seeking your commitment to these changes to the planning system in the next term of government and urge you to update your Report Card score by letting us and the Alliances know that you support these changes.
