

About

The Eastern Alliance for Greenhouse Action (EAGA) is a formal collaboration of eight councils in Melbourne's east, working together on regional programs that reduce greenhouse gas emissions and facilitate adaptation. The Alliance implements joint initiatives that provide economies of scale and enable projects typically beyond the reach of individual councils. EAGA's project work is complemented by advocacy, capacity building and regional partnerships.

Impact

Since its inception in 2012, the net benefits of EAGA's work in the region has amounted to ~7 times the amount invested by its member councils in the form of membership fees and project costs.

Chair Person's Statement

Against the backdrop of developments in climate policy at the federal and state levels, EAGA continues to provide leadership in climate action at the local level in Melbourne's east. This year, EAGA's eight-member councils have sustained their collaboration on several projects that address the causes and effects of climate change.

EAGA projects continue to deliver clear financial and environmental outcomes for our member councils. The twelvemonth evaluation of the Victorian Energy Collaboration (VECO) shows councils have saved 25% on delivered energy costs and reduced greenhouse gas emissions by 172,000 tonnes. The Business Renewable Buying Group (BRBG), another initiative supported by EAGA's member councils, completed its pilot in June. The businesses engaged in the pilot finalised contracts for a 100% renewable energy supply over the next five years. These contracts will result in the mitigation of over 16,000 tonnes of emissions. EAGA will continue to support the next phase of the project, which looks to expand Victoria -wide and target larger group purchases.

Efforts are increasingly focusing on driving down emissions within the community. EAGA coordinated a technical analysis that showed the most cost-effective opportunities for emissions reduction across Melbourne's eastern municipalities. The analysis reveals the potential for the region to achieve savings of \$3-\$5 billion by transitioning to net-zero emissions by 2030. The report also underscores that councils can unlock 7%–15% of this potential through various interventions, such as urban planning, landfill waste diversion and supporting the transition to EVs. Nonetheless, the analysis underlined that all sectors of the economy and community have a role to play in decarbonisation affirming the need for tackling emissions in a coordinated manner.

Phase II of the Adaptive Community Assets project continued EAGA's commitment to supporting climate change adaptation. The project's development of financial estimates of climate change costs to council assets is crucial to helping councils understand their risk exposure. EAGA's members will support future project phases to capture the cost of climate effects as this evolves.

Finally, once again this year, EAGA's advocacy endeavours, united with the Victorian Greenhouse Alliances, have yielded substantial impact through coordinated efforts aimed at state and federal governments. This included leading a state-wide campaign, along with the Council Alliance for a Sustainable Built Environment (CASBE), to embed climate change into all planning decisions. 65 of Victoria's 79 councils participated in the Planning for a Safe Climate campaign – one of the largest local government campaigns in recent times. It involved engaging with MPs in the lead up to the 2022 Victorian state election, resulting in crossbench MPs raising the campaign in parliament.

I want to thank my fellow representatives on the Executive Committee, the Steering Committee and our staff for their hard work in achieving these important outcomes at a time when such partnerships across many sectors are vital.

Summary of 2022–23 Outcomes Against Strategic Plan

Strategy Direction	Initiatives	Outcomes
Mitigation and adaptation projects	Victorian Energy Collaboration (VECO)	A 12-month evaluation of VECO demonstrated that the transformational initiative provided 51 councils with 25% cheaper electricity through 100% renewable energy. Councils saved approximately 172,000 tonnes of greenhouse gas emissions in the period, which is equivalent to powering up to 35,000 homes or taking 66,000 cars off the road each year. Six EAGA members are participating in the project, which was initiated by EAGA and the Victorian Greenhouse Alliances and was led by Glen Eira City Council for two years.
	Energy Savers	Energy Savers is a program assisting businesses undertake energy efficiency upgrades with subsidised appliances and equipment. In 2022–23, the program engaged with 1,218 businesses to help cut their emissions. Moreover, the program successfully assisted 26 businesses across the region to receive over \$0.5M in federal funding to undertake energy efficiency upgrades. Energy Savers is being administered by Monash City Council on behalf of the eight participating councils.
	Solar Savers	Solar Savers has continued to deliver substantial financial savings and emissions reductions for households across the region. The program delivered ~1,300kW of rooftop solar in the last 12 months which will cut emissions by over 1,500 tonnes per year. This included two rates programs involving councils investing their own funds to pay the up-front costs of solar systems on vulnerable households and recouping the funds via rates charges. Maroondah Council has continued its leadership role by administering the program and hosting the Solar Savers team.
Capacity building and information exchange	Adaptive Community Assets	The second phase of this DEECA-funded project developed financial estimates of the costs of climate change impacts on each asset class for all participating councils. It found damages to council assets will increase about 150% by 2050 and 350% by 2100. This 'baseline' or 'base case' is a critical first step in a cost-benefit analysis framework for assets and assists councils to understand their risk exposure to these assets without climate change adaptation. The project was delivered in partnership with four metropolitan Greenhouse Alliances.
	Community Net Zero Technical Analysis	EAGA undertook a technical analysis project to quantify the lowest cost emissions reduction opportunities across the municipalities in Melbourne's east. The report examined the various interventions that councils can undertake to unlock these opportunities. The analysis demonstrates that the region can save \$3-\$5 billion by transitioning to net zero emissions by 2030. The report identifies that councils can unlock up to 15% of this potential through a range of different interventions, but all sectors of the community have a role in decarbonisation.
	Victorian Greenhouse Alliances Conference	EAGA officers played a key organisational role in the conference, held on 4 August 2023. The event attracted over 400 attendees – the majority from local government – for a day of learning and networking. Session topics included the role of councils in facilitating emissions reductions in the transport sector, the key lessons from the Neighbourhood Battery Initiative, and improving community resilience in the face of climate change impacts.
Advocacy	Low income and vulnerable households	AusNet approved EAGA's proposal to fund an electrification pilot for vulnerable households. The pilot seeks to better understand the impact of electrification on households, both from a network perspective and a vulnerable customer perspective. The energy provider will allocate \$1.5M to the initiative over the next couple of years. AusNet will partner with councils to facilitate engagement with households and leverage existing on-ground programs and campaigns focusing on electrification, such as Solar Savers.
	Submissions and Engagement	EAGA and the Victorian Greenhouse Alliances have generated further impact through coordinated advocacy to state and federal government. EAGA's submissions included providing eight key recommendations to the review of the Australian Carbon Credit Units, three recommendations for amendments to the Safeguard Mechanism, and a response to the state parliamentary inquiry into the 2022 flood event in Victoria.

"Last year, Boroondara City Council both declared a Climate Emergency and voted in ambitious Climate Action and Implementation Plans. Assisted by these documents, Council has achieved net zero across its corporate activities but progress towards our community targets, which represent 98%-99% of the municipality's greenhouse gas emissions, was very disappointing.
