The Eastern Alliance for Greenhouse Action (EAGA)

is a formal collaboration of eight councils in Melbourne's east. Our mission is to unite and empower our region to forge a climate resilient, genuine net zero future for all. The alliance implements joint initiatives with a focus on driving the region to genuine net zero and building climate resilience and adaptive capacity. This work provides economies of scale and enables projects typically beyond the reach of individual councils. We work to empower councils and communities through knowledge and information sharing and seek to drive systemic change through evidence-based advocacy.

Impact

Since its inception in 2012, the net financial benefits of EAGA's work in the region have amounted to approximately 12 times the amount invested by its member councils in the form of membership fees and project costs.

Renewed Commitment and Strategic Direction

In 2024-25, EAGA has continued to foster vital collaboration among our member councils, delivering impactful projects and leading shared advocacy that drives regional climate action. A significant highlight has been the reaffirmation of commitment from all eight member councils for the next four years, cemented by new Memorandums of Understanding and the finalisation of our 2025-30 Strategic Plan. This renewed dedication underscores the strong partnership and shared resolve to confront climate change in our region head-on.

Key Achievements from the Past Year

This year saw considerable progress across our initiatives:

- Expanded Solar Savers Program: Reaching even more residents and businesses, this program has resulted in an estimated 18,098 tonnes of CO2 equivalent emissions saved. The program is also continuing to expand, now involving twenty participating councils in the 2025–26 period, including all eight EAGA members. In 2025, the program expanded to include a wide range of products to support the electrification goals of councils, such as hot water systems, EV chargers and insulation.
- 'Reporting FOGO Impacts' Project: This project demonstrated the substantial emissions savings achieved by our food waste programs. Findings showed that


- the total emissions reduction impact of FOGO programs across the EAGA region was an impressive 44,046 tonnes of CO2 equivalent in 2023–24 alone.
- Collaborative Advocacy: We continued our advocacy efforts, making nine submissions to state and federal governments and electricity distribution businesses, covering issues related to planning, electrification, infrastructure, electricity pricing, household energy upgrades and more. EAGA is also an active member of the Renew Australia for All campaign which demonstrated huge collective impact in the lead up to the 2024 federal election by securing the \$2.3B funding commitment for the Cheaper Home Batteries Program.

Forging a Resilient Future Together

These achievements demonstrate the power of working together as a region. They embody our newly articulated mission, which underpins our 2025-30 Strategic Plan: "Uniting and empowering our region to forge a climate resilient, genuine net zero future for all."

I extend my sincere gratitude to my fellow representatives on the Executive Committee, the council officers on the Steering Committee, and our dedicated staff for their unwavering hard work. Their commitment is paving the way for a more sustainable and resilient future for all in Melbourne's east.

Summary of 2024–25 Outcomes Against Strategic Plan

Strategy Direction	Initiatives	Outcomes
Mitigation and adaptation projects	Victorian Energy Collaboration (VECO)	VECO is the largest emissions reduction project ever undertaken within the Australian local government sector. Since commencing in 2021, 60 councils across Victoria have saved ~750,000 tonnes of greenhouse gas emissions and ~\$16M in cost savings. EAGA councils have cut their emissions by 87,000 tonnes and reduced costs by \$1.4M over the 2024–25 period.
	Solar Savers	The scope of Solar Savers expanded to include additional upgrade options including air conditioning, hot water heat pumps, induction cooktops, insulation, EV charging and home energy assessments. A new panel of vetted installers were engaged and an online platform was launched which provides tailored information to householders on the cost and benefits of each upgrade option. As of June 2025, Solar Savers membership has grown to 20 councils, including all 8 EAGA members. A strategic partnership was established with the State Electricity Commission (SEC) including the execution of an MOU between the parties to collaboratively deliver a number of small 'one-stop-shop' pilots. Solar Savers recently celebrated the installation of the 1000th solar PV system and has saved the community over \$5.4M on energy bills since the program began.
	Business Renewables Buying Group (BRBG)	The second buying group of businesses from across Victoria was finalised in late 2024, representing a total of 81,957 MWh of electricity use over the five-year contract. This will result in 65,566 tonnes of emission savings over five years. The formation of a third buying group is well underway and due to be finalised in the second half of 2025.
Capacity building and information exchange	Reporting FOGO Impacts (Phase 2)	The Reporting FOGO Impacts project was developed to assist councils to quantify the impact of their programs via a consistent and robust methodology. Project outputs included the creation of an emissions calculator tool that allows any Australian council to track and report on the emissions reduction impact of their FOGO program. Project findings provided a number of insights, including the impact of bin collection frequency and universal roll-out.
	Victorian Greenhouse Alliances Conference	EAGA officers played a key organisational role in the conference, held on 30 August 2024. The event attracted over 400 attendees – the majority from local government – for a day of learning and networking. The 2025 conference on 22 August will include session topics such as climate risk management, decarbonising construction and First Nations climate knowledge.
Advocacy	Federal Advocacy	In August 2024, EAGA signed up to the Renew Australia For All campaign with approximately 70 other civil society organisations. The campaign was instrumental in winning the \$2.3B home battery storage package – the second largest financial commitment made by Labor in the lead up to the election. Significant advocacy efforts were made this year, including numerous meetings with government ministers and advisors on seeking federal government investment to scale home upgrades programs such as Solar Savers, particularly for vulnerable and low-income households.
		On behalf of the Victorian Greenhouse Alliances, EAGA has also led a call for the establishment of a Multi-Level Governance pilot for climate action. The intent of the pilot is to create a replicable and scalable framework that will demonstrate how Australia's three tiers of government can work together in partnership to identify shared objectives and actions to strengthen climate mitigation, adaptation and resilience.
	Submissions and Engagement	In 2024–25, EAGA collaborated with other Victorian Greenhouse Alliances on 9 advocacy submissions. These included a focus on electrification with submissions to the Victorian Government on both the Building Electrification Regulatory Impact Statement and Victorian Energy Upgrades Strategic Review. Collaboration with the Council Alliance for a Sustainable Built Environment (CASBE) continued, with a shared response to the draft Ministerial Direction on Climate Change Consideration in the planning system.

The alliance helps to greatly amplify our efforts and provide significant strategic and operational support to assist with the implementation of Knox's Climate Response Plan. One key aspect of our Climate Response Plan has been to replace streetlights with energy efficient LEDs. The advocacy efforts of EAGA have greatly assisted Knox City Council in receiving close to \$600,000 in rebates from our local energy distributor. As an EAGA member. Knox has also had the opportunity to host the Business Energy Savers program this year, as part of our collaborative effort with other energy savers Councils. EAGA also plays an instrumental role in a range of advocacy efforts that represent the interests of Knox City Council and our Climate Response Plan goals, as well as facilitating and/ or supporting the ongoing success of various priority projects including the Victorian Climate Resilient Councils program and Adaptive Community Assets project. We are confident that our ongoing collaboration through EAGA on these important strategic issues and projects will greatly help meet the needs of Council and the community in striving for net zero and climate resilience."

"In 2024–25, our EAGA membership continued to provide significant emissions and cost savings across Council's operations and the Maroondah community. Through EAGA, Council has access to valuable resources, expertise, and collaborative opportunities, supporting the outcomes of our Sustainability Strategy 2022–31. Maroondah continues to benefit from the Victorian Energy Collaboration (VECO), transitioning our street lighting onto 100% renewable electricity from January 2025, delivering further emissions and costs savings. Climate change adaptation and resilience building has also been a key priority. Projects including Adaptive Community Assets – Phase 3: Costs and benefits of adaptation options for roads, and the Victorian Climate Resilient Councils (VCRC) project, will support the ongoing work to embed climate change into long term risk and financial planning.

"Last year, the City of Boroondara adopted its updated Climate Action Plan (CAP) Implementation Plan for 2025–26 and 2026–27. This plan reinforces our commitment to reducing emissions across our city and to building community resilience. Over the past year, EAGA has continued to be a vital partner in helping us achieve our climate action goals, through a range of programs and advocacy. The updated Solar Savers program, now offering a panel of vetted suppliers, will help Boroondara residents electrify their homes, while the Energy Savers program continues to help local businesses cut costs and emissions. This past year also saw the completion of EAGA's FOGO project, providing councils with practical tools, including a Boroondara-specific emissions reduction calculator tool, to improve services and outcomes. A recent highlight was the Victorian Greenhouse Alliances Conference in August, (EAGA is an ongoing member), where hundreds of LGA practitioners and decision-makers came together to hear presentations from various councils and subject matter experts, and broaden our networking base.

In summary, Boroondara receives invaluable benefits from its EAGA membership. The EAGA alliance forums that allow effective knowledge and solution sharing, its collaborative projects, and its strong advocacy at all government levels, are essential to helping us efficiently deliver our Council's climate action goals."

Our inclusion in the EAGA sponsored Victorian Energy Collaboration (VECO) scheme, delivering 100 per cent renewable electricity, has been a fundamental part of Monash achieving net zero emissions. Overall, our partnership with the Alliance remains central to achieving our Net Zero goals, improves our ability to build resilience to climate change, provides a significant level of advocacy at state and federal levels, and reflects our commitment to a sustainable, low-carbon future for all who live and work in Monash."

"At a time when leadership in the transition to zero emissions is increasingly needed, EAGA plays a significant role in providing the research, advocacy and collaborative capacity to assist councils in this critical task. By pooling resources, participating councils can achieve outcomes that would be difficult to deliver alone. The Shire faces severe challenges from climate change, but cooperation with EAGA can enable Council to make the most of the opportunities a green local economy can bring.

The research base that EAGA provides has informed our policy development in community-focused climate mitigation and adaptation, such as our Draft Energy Transition Plan and the Liveable Climate Action Plan 2020–30. As we continue on the journey to zero emissions, we will continue to draw on the strategic insight that EAGA can provide for action within council and for advocacy to State and Federal Governments. We face a daunting challenge, but in collaboration we are most likely to achieve the goal of a sustainable future.

"This year, Whitehorse City Council completed the transition of all services to the Victorian Energy Collaboration (VECO), securing 100% renewable electricity for all of Council's supply, delivering long-term cost savings and emissions reductions. Without EAGA's involvement, this flagship initiative would not have been possible. EAGA's coordinated advocacy has also influenced climate commitments and improved funding for local sustainability. A standout achievement was progress through the Electricity Distribution Price Review, with local energy distributors now seeking to undertake large scale, energy efficient public lighting upgrades including within the Whitehorse municipality.

Council is also excited to utilise the Food Organics Garden Organics Impacts Calculator that has been developed. This innovative and tailored tool will help councils quantify and communicate on emissions reduction benefits from organics diversion moving forward. These milestones highlight EAGA's continued leadership in driving practical, collaborative climate action. Council looks forward to supporting this work through its renewed commitment for the 2025–29 MOU period.
